Minutes

Present: Vice Chairman Mary Carey (MC), Councillors John Adams (JA), Andy Salmon (AS), Councillor Stephen Day (SD) and Nicki Clarke (NC), District Councillor Jerry Avery (J. Avery) and County Councillor Anda Fitzgerald O'Connor (AFO)

Also present: Allison Leigh, Clerk (AL)

The council held a minute's silence to remember the life of Prince Philip, Duke of Edinburgh.

21/1: Apologies for Absence: Chairman Liz Gilkes (LG)

21/2: Declarations of interest: None.

21/3: Public questions and statements: Two members of the public were in attendance – one to listen to the meeting and Felicity Dick to report on her plans for a Green Group in the village. District Councillor Paul Barrow was in attendance to discuss biodiversity. He reported the Vale of White Horse District Council is holding a Nature Forum on 24th May.

AS noted that if areas are turned over to nature, these areas still need to be maintained. The question arose as to whether or not these areas can be walked on.

21/4: Reports from District and County Councillors:

Oxfordshire County Council (OCC)

AFO reported she will not be standing again for County Councillor. The council thanked her for her supportive service to the Parish Council.

AFO reported she will still be involved with her charities.

AL asked AFO if she could try and get in touch with the footpaths officer as the council has tried several times to no avail. AFO said she would and had been trying as well.

AS asked if AFO could check into the drains being cleared before she leaves office.

Vale of White Horse District Council (VoWHDC)

J. Avery sent the following report:

1. Lioncourt Strategic Land - Application to build 660 houses on LEKB (Land East of Kingston Bagpuize)

Further to my last wrt to this matter, I fully expect Lioncourt to appeal and resubmit its application but have no details at the moment.

Government White Paper - Planning - 2020

Further to my last wrt to this issue I fully expect the government white paper to be the basis for draft legislation that will effectively erode local democracy and by making it more difficult for local people to raise objections to proposed developments and hence make it easier for developers to obtain planning permission.

2. The Oxford - Cambridge ARC

This is a matter that is likely to concern and plague us to some considerable degree in the near future because the government is to establish a growth board with a view to resurrecting the proposal to create a growth zone across 5 counties (Oxfordshire, Bucks, Northants, Beds and Cambridgeshire). Why the government should be so keen on this proposal is unclear; inter alia, it ignores the so-called "levelling-up" option (promoting development) wrt the north of the UK. Of course, were it to go ahead it would mean building about 1 million new homes across all 5 counties. Alarmingly, when you tie this proposal to what is contained in the white paper (see above), it is clear that future legislation could well make it much more difficult for local residents to object to proposed developments near to them.

3. Local Issues

I have provided the parishes in Thames Ward with a small measure of financial support to ensure that the Comet Bus Service can continue to serve the vulnerable in the community. I was originally given £2000 to help PCs out and have so far handed over £1750. I would, of course, welcome a request for further funding up to £250.

MC asked if Lioncourt will appeal or put in a new application. J. Avery reported that they may appeal or may wait for the government's white paper to come out as they have 6 months to appeal. MC reported that AWE PC had sent in a detailed response to the white paper.

Felicity Dick (FD) joined the meeting at this stage as she is interested in creating a wider biodiversity initiative village in the village. Paul Barrow mentioned again the Vale's biodiversity meeting in May. FD noted that she has been working with others in the village interested in biodiversity. She will attend the forum in May and look to form a Steering Group.

21/5: Minutes of the last meeting: The minutes of the Meeting of the 8th March 2021 were approved and signed as a true record.

21/6: Matters arising from the previous meetings and not appearing elsewhere on the agenda: None

21/7: Clerk's report: The Clerk's Report was acknowledged and there were no comments on it.

21/8: Website: AL reported that the website is nearly complete and she is hopeful for it to go live in May.

21/9: In-person meetings after 7th May 2021: The council discussed the end of legislation allowing virtual meetings after the 7th May 2021. The council resolved to hold the May meeting on the 6th May virtually and will then review the date for the June meeting at that time.

21/10: Parking:

- **Green Lane outside the playground:** It was reported that several residents have sent reports and photos of vehicles parked illegally by the playground. There are signs there, but they are difficult to read. AS noted that better signs are needed and agreed to create some verbiage for new signs and circulate it.

The council also would like a piece on this to be placed in the May advertiser.

- **School parking:** The council discussed the production of banners at the school and will contact the school. AL noted that she had seen stand-up signs at Cumnor that seemed quite good and will contact the school about these.

21/11: Damage to the sportsfield: JA reported there had been some damage to the sportsfield and it is known who caused the damage. The damage has been repaired by local residents. The council discussed purchasing CCTV. NC noted that there is a code with which the council would need to comply. AL and NC will discuss this. AL will look into costs for CCTV. CCTV will go on the May agenda.

21/12: Vale of White Horse call for sites: It was noted that the Call for Sites for the Vale of White Horse and South Oxfordshire District Council's Joint Local Plan 2041 is now on the Vale's website. MC reported she has e-mailed the Vale about several inaccuracies. The council noted it needs to be alert to the Joint Local Plan process.

21/13: Social Media: AL reported she had been on a crisis communication course where instructor noted that there is an expectation for organisations such as parish councils to have be on some kind of social media. There was a discussion as to what type/platform might be best were AWE PC to consider this.

The council resolved to get the new website up and running and then look to discuss again. The council will also look at what other parishes do.
